This allows an agency to ensure the integrity of the report number between the CAD and the crash report. While the ability to export data from LETS has been an option to agencies, this change allowed data to be imported.
10/9/2019	Add new Not-Accepted STARS Status search options to drop-down list, on crash search page.
9/18/2019	Criminal incident flag – this field has been added to the crash report basics page. This flag is configurable through the agency settings, so that an agency can decide if they want this to be a required field.
9/18/2019	Edit Report Number button – the Edit Report Number button was removed and the functionality was updated to be controlled by permissions determined in the agency settings.
6/26/2017	Reports: Some of the user interface for reporting has been changed to make it more user friendly. Also, the Collision Summary report is now working.
6/26/2017	Narrative Form: The Reviewing Officer 1 and 2 drop down lists are now disabled until the 'Ready for Review' checkbox is checked. Also, audit textboxes have been added to indicate who (and when) added the reviewing officer.

6/26/2017	Agency Header: The Agency header on the Main Menu been made more visible.
6/26/2017	Date fields: All date fields are now formatted as mm/dd/yyyy.
6/26/2017	Driver Info Exchange: Now contains the insurance company phone number.
6/26/2017	Vehicle form, License Plate Type: There is now a complete list of license plate types along with a link that provides a description for each. These descriptions are also located on the Help tab.
6/26/2017	Administration, LETS Notify: On the User form there is now a LETS Notify checkbox. When checked, this user will receive notify messages when the LETS Notify checkbox on the Agency form (when checked) will send messages to all personnel that have the checkbox checked on their User form. Admins will default to having their User form checked. If the Agency form check box is not checked then all personnel whose User form is checked will be copied on notify messages.

12/15/2016	In the Driver/Vehicle section, the Insurance Company and Tow List functionality has been updated. The 'drop down lists' are now always available, there is no longer a need to toggle between 'List' and 'New'.
